Separate sealed Bids for **Lynnewood Elementary School** shall be received by Mr. Robert Riegel, Business Manager until 10:00 am prevailing local time, Friday, March 22, 2019. Bids shall be received at Haverford Township School District Administration Building, 50 Eagle Road, Havertown, PA 19083. Bids will be publicly opened and read aloud immediately after specified closing time, at 10:00 am.

Work will be bid as the following Prime Contracts:

Contract No. 1 General Construction

Contract No. 2 HVAC Construction

Contract No. 3 Plumbing Construction

Contract No. 4 Electrical Construction

Bidding Documents will be available Monday, February 25th, 2019 at 3:00 pm.

Bidders are required to secure a complete set of Bidding Documents for all contracts. A complete set of Bidding Documents may be secured only at the offices of KCBA Architects, 8 East Broad Street, Hatfield, Pennsylvania, 19440 (Phone: (215) 368-5806) in accordance with the Instructions to Bidders.

A fee of two hundred dollars (\$200), payable to the Architect, is required for one set of Bidding Documents on CD in .PDF electronic format. An additional non-refundable twenty-five dollar (\$25 fee) will be required for each set of Bidding Documents if the documents are to be mailed to the bidder. A separate bank check is required for the additional fee. No additional fee will be required for UPS or Federal Express delivery of documents if Bidder provides a valid account number for delivery service. Documents will not be mailed until fees are received at Architect's offices in cash or bank check.

A **mandatory pre-bid meeting for all prime contracts, GC, MC, PC, EC** will be held at the Auditorium of Lynnewood Elementary School on Wednesday, March 6, 2019 at 2:30 pm. Lynnewood Elementary School is located at 1400 Lawrence Road, Havertown, PA 19038.

Each Bid must be accompanied by a Certified Check, money order or cashier's good faith check payable to the Order of **School District of Haverford Township** or Bid Bond in an amount not less than 10 percent (10%) of the total bid, as security, Performance and Payment Bonds are required. Each Bid must be accompanied by a Non-Collusion Affidavit in the form set forth in the Bidding Documents.

The right to waive any informality in any Bid, to reject any or all Bids or to award any Contract in the best interest of the Owner is reserved.

Bidders on this Work and all subcontractors shall comply with all provisions of the Pennsylvania Prevailing Wage Act.

Bidders on this Work and all subcontractors shall comply with all provisions of the Pennsylvania Commonwealth Procurement Code for Prevention of Environmental Pollution.

It is intended to award multiple prime contracts for the work as follows: General Construction, Plumbing Construction, Mechanical Construction, and Electrical Construction.
