Separate sealed Bids for ADA, Title IX, Athletic Maintenance Modernization Project for the Boyertown Area School District shall be received by William Gasper, District Facility Engineer, until 10:00 am, prevailing local time, March 5, 2019. Bids shall be received at Boyertown Area School District Supportive Services Building, 1131 Montgomery Avenue, Boyertown, PA 19512. Bids will be publicly opened and read aloud immediately after specified closing time.

It is intended to award multiple prime contracts for the work as follows:

Contract No. 1	Site Work / Demolition Construction (Rebid)
Contract No. 2	Electrical Construction (Previously bid – to be awarded)

Revised Bidding Documents will be available February 25, 2019 after 2:00 pm.

New bidders are required to secure a complete set of Bidding Documents; previous bidders may utilize drawings from previous bid with new forthcoming addenda. A complete set of Bidding Documents may be secured only at the offices of KCBA Architects, 8 East Broad Street, Hatfield, Pennsylvania, 19440 (Phone: (215) 368-5806) in accordance with the Instructions to Bidders.

A nonrefundable fee of one hundred dollars (\$100.00), payable to KCBA Architects, is required for one set of Bidding Documents on CD in .PDF electronic format. An additional non-refundable fee of twenty dollars (\$20) will be required for each set of Bidding Documents if the documents are to be mailed to the bidder. A separate bank check is required for the additional fee. No additional fee will be required for UPS or Federal Express delivery of documents if Bidder provides a valid account number for delivery service. Documents will not be mailed until fees are received at Architect's offices in cash or bank check.

Each Bid must be accompanied by a Certified Check, money order or cashier's good faith check payable to the Order of Boyertown Area School District, or Bid Bond in an amount not less than 10 percent (10%) of the total bid, as security.

Performance and Payment Bonds are required. Each Bid must be accompanied by a Non-Collusion Affidavit in the form set forth in the Bidding Documents.

The right to waive any informality in any Bid, to reject any or all Bids or to award any Contract in the best interest of the Owner is reserved.

Bidders on this Work and all subcontractors shall comply with all provisions of the Pennsylvania Prevailing Wage Act.

Bidders on this Work and all subcontractors shall comply with all provisions of the Pennsylvania Commonwealth Procurement Code for Prevention of Environmental Pollution.
